



# Hydro One Remotes: 2025 Customer Satisfaction Survey contest

# Rules and regulations October 1, 2025, to November 26, 2025

By entering the Contest (defined below), entrants agree to abide by these Rules and Regulations and will be deemed to have received, understood and accepted these Rules and Regulations by participating in the Contest.

Hydro One Remote Communities Inc. (hereinafter "Hydro One Remotes") **2025 Customer Satisfaction Survey Contest** (the "Contest") will run from 10:00 a.m. ET on October 1, 2025, until 11:59 p.m. ET on November 26, 2025 (the "Contest Period").

## **Entry**

No purchase necessary but must be received by one of the means below.

#### **TELEPHONE ENTRY**

Hydro One Remotes' customers who successfully complete the 2025 Customer Satisfaction Survey during the Contest Period by telephone will be eligible for a chance to win an energy efficient toaster oven or another small appliance of approximate value of \$100 CDN to be determined by Hydro One Remotes.

#### **ON-LINE ENTRY**

Hydro One Remotes' customers who successfully complete the 2025 Customer Satisfaction Survey during the Contest Period by visiting <a href="https://www.hydrooneremotes.ca">https://www.hydrooneremotes.ca</a> and following the instructions that appears on his/her/their computer screen will be eligible for a chance to win an energy efficient toaster oven or another small appliance of approximate value of \$100 CDN to be determined by Hydro One Remotes.

The nature of the survey to which a Hydro One Remotes' customer provides responses, and the responses provided to the survey, have no effect upon that Hydro One Remotes' customer's chances of winning a prize in the Contest.





Limit of one entry per household. The Contest is open to Hydro One Remotes' customers at the time of the draw. Entrants must be residents of Ontario, eighteen (18) years of age or over.

Any other method of entry is void. Non-compliance with any entry procedure will result in disqualification.

All entries must be received by 11:59 p.m. ET on November 26, 2025.

### **Contest prizes**

THREE (3) prizes total are available to be awarded to Hydro One Remotes' customers. Each prize is ONE (1) energy efficient toaster oven or another small appliance of approximate value of \$100 CDN to be determined by Hydro One Remotes.

#### **Prize draw**

On or about 10:00 a.m. ET on December 1, 2025, in Thunder Bay, Ontario, Hydro One Remotes will randomly select THREE (3) entries from all eligible entries received. To win, selected entrants must correctly answer the mathematical skill-testing question and must return the properly executed release form within the specified time. A selected entrant will be notified by telephone or email approximately the first week following the draw. If the skill-testing question is answered incorrectly, or if a selected entrant does not respond to the attempts to contact him/her/they or the properly executed release form is not returned within the specified time, then he/she/they will be disqualified from the Contest and an alternate entry will be randomly drawn from the pool of eligible entries. If a selected entrant cannot be reached within 14 days after the first attempt of notification, his/her/their opportunity to win the prize will be forfeited and another selected entrant will be randomly drawn. Hydro One Remotes will not be responsible for failed attempts to contact a selected entrant.

#### **General rules**

The Contest excludes employees, agents and representatives of any of the following, and anyone with whom such persons are living (whether related or not) and a member of any such person's immediate family (regardless of where they live): Hydro One Remote Communities Inc., its advertising and promotional agencies, and their affiliated companies. Regulations, "immediate family" includes mother, father, brother, sister, son, daughter, partner and/or spouse.

Chances of winning depend on the number of eligible entries received. Entries are subject to verification by Hydro One Remotes, in each case in its sole discretion. The Contest is subject to all applicable federal, provincial, and municipal laws and regulations. All decisions of the judges are final, and the Released Parties (defined below) shall not be responsible for any errors or negligence that may occur in connection with the Contest.

Each selected entrant will also be required to sign a declaration and release form (the "Release Form") confirming compliance with these Rules and Regulations, acceptance of the prize as awarded, without substitution and releasing Hydro One Remote Communities Inc., its affiliated and related companies, advertising and promotional agencies, and their respective shareholders, directors, officers, employees, agents, representatives, successors and assigns (collectively, the "Released Parties") from any liability in connection with the prize or the Contest. The Release Form must be returned within the time period specified on the Release Form or the prize will be forfeited.
